

PROMOTION TERMS AND CONDITIONS "IKONKA DAYS - DISCOUNT ON PALLET ORDERS"

§1. General Provisions

1.1. These terms and conditions ("Terms and Conditions") define the rules of the promotion named "Ikonka Days - discount on pallet orders" ("Promotion"), organized by KIK Spółka z ograniczoną odpowiedzialnością Spółka komandytowa with its registered office in Białystok, at Al. Tysiąclecia Państwa Polskiego 8, 15-111 Białystok, entered into the register of entrepreneurs kept by the District Court in Białystok, XII Economic Division of the National Court Register under the number 0000613970, NIP: 5423089180, REGON: 200218804, hereinafter referred to as the "Organizer."

1.2. The Promotion is addressed exclusively to entrepreneurs making purchases as part of their business activity ("B2B Clients").

1.3. The Promotion does not apply to consumers or privileged entrepreneurs within the meaning of Art. 385⁵ of the Civil Code.

§2. Conditions for Participation in the Promotion

2.1. The Promotion covers orders placed from **March 9, 2026, to March 13, 2026**, with the possibility of extending or shortening the duration by the Organizer's decision.

2.2. The Promotion consists of granting a **5% discount** on the assortment included in the campaign, provided that an order is placed in full-pallet quantities.

2.3. The discount is calculated automatically in the B2B sales system after adding products in the required pallet quantity to the basket.

2.4. The Promotion applies only to orders placed and paid for in accordance with the Organizer's applicable wholesale sales rules.

2.5. The discount does not include transport costs unless other current promotions state otherwise.

§3. Rules for Placing and Fulfilling Orders

3.1. Orders under the Promotion should be placed via the B2B sales system or another channel established with the Organizer's sales representative.

3.2. The Promotion **cannot be combined** with other discounts, promotions, or individual commercial conditions, unless the Organizer decides otherwise.

3.3. The Organizer reserves the right to verify the compliance of the order with the Promotion conditions (in particular, verification of pallet quantities) before its fulfillment.

3.4. Deliveries are carried out in the pallet transport standard via carriers cooperating with the Organizer.

§4. Returns and Complaints

4.1. Due to the nature of B2B transactions, the Client is not entitled to the right to withdraw from the contract on the terms provided for consumers.

4.2. The Organizer does not accept returns of full-value goods purchased under the Promotion.

4.3. Complaints regarding the quality or compliance of the delivery with the order are considered on the general terms applicable in wholesale sales, in accordance with the applicable commercial conditions.

§5. Changes and Termination of the Promotion

5.1. The Organizer reserves the right to change the Promotion conditions, suspend, or terminate the Promotion prematurely, in particular in the event of changes in logistics or market costs or other significant economic circumstances.

5.2. Changes to the Terms and Conditions come into force upon their publication on the Organizer's website or their communication to Clients in another accepted manner.

5.3. Changes to the Terms and Conditions do not affect the rights of Clients who have already placed orders meeting the Promotion conditions before the day the changes come into force.

§6. Final Provisions

6.1. In matters not regulated, the provisions of the Civil Code shall apply.

6.2. Any disputes will be resolved by the court having local jurisdiction over the Organizer's registered office.

6.3. The Terms and Conditions come into force on March 9, 2026.
