# TERMS & CONDITIONS OF THE "FREE DELIVERY FOR WHOLESALE ORDERS" PROMOTION (20–31 OCTOBER 2025)

#### §1. General Provisions

- 1.1. These Terms and Conditions ("Terms") define the rules of the promotion called "Free Delivery for Wholesale Orders" ("Promotion"), organized by KIK Spółka z ograniczoną odpowiedzialnością Spółka komandytowa, with its registered office in Białystok, Al. Tysiąclecia Państwa Polskiego 8, 15-111 Białystok, Poland, entered in the Register of Entrepreneurs maintained by the District Court in Białystok, 12th Commercial Division of the National Court Register under number KRS 0000613970, NIP: 5423089180, REGON: 200218804, hereinafter referred to as the Organizer.
- 1.2. The Promotion is addressed exclusively to business entities making purchases within the scope of their business activity (B2B Clients).
- 1.3. The Promotion does not apply to consumers or entrepreneurs with consumer rights as defined in Article 385<sup>5</sup> of the Polish Civil Code.

## §2. Conditions of Participation

- 2.1. The Promotion applies to orders placed between 20 October 2025 and 31 October 2025, unless extended or shortened by decision of the Organizer.
- 2.2. The Promotion consists of free delivery for orders with a minimum net value of €3,000 (three thousand euros).
- 2.3. Orders that require parcel shipments or incomplete pallets may be excluded from the Promotion or subject to an additional logistics fee, of which the Client will be informed before dispatch.
- 2.4. The Promotion applies only to orders placed and paid in accordance with the Organizer's wholesale sales terms.
- 2.5. Free delivery applies only within the European Union.
- 2.6. The Promotion does not apply to import orders placed on behalf of third parties.

#### §3. Ordering and Fulfilment Rules

- 3.1. Orders under the Promotion shall be placed via the Organizer's B2B sales system or through other channels agreed with the Organizer's sales representative.
- 3.2. The Promotion cannot be combined with other discounts, promotions, or individual trade conditions, unless otherwise decided by the Organizer.

- 3.3. The Organizer reserves the right to verify the value of the order and its compliance with the Terms before fulfilment
- 3.4. Deliveries under the Promotion are made through carriers cooperating with KIK Sp. z o.o. Sp. k. under standard pallet transport conditions. The choice of carrier rests with the Organizer and may vary depending on the delivery location, order size, or other logistical factors.

## §4. Returns and Complaints

- 4.1. The Promotion applies exclusively to B2B transactions, and therefore no right of withdrawal as provided for consumers under the Polish Consumer Rights Act applies.
- 4.2. The Organizer does not accept returns of non-defective goods purchased under the Promotion.
- 4.3. Complaints regarding product quality or delivery discrepancies will be handled under the Organizer's general wholesale terms and conditions.

## §5. Modifications and Termination of the Promotion

- 5.1. The Organizer reserves the right to modify, suspend, or terminate the Promotion at any time, particularly due to changes in logistics costs, market conditions, or other significant economic circumstances.
- 5.2. Any changes to these Terms shall take effect upon publication on the Organizer's website or notification to Clients by other accepted means.
- 5.3. Changes to the Terms shall not affect the rights of Clients who have already placed orders meeting the Promotion conditions prior to the effective date of such changes.

# §6. Final Provisions

- 6.1. Any matters not regulated herein shall be governed by the provisions of the Polish Civil Code.
- 6.2. Any disputes arising in connection with these Terms shall be resolved by the court having jurisdiction over the Organizer's registered office.
- 6.3. These Terms enter into force on 20 October 2025.
